


# Green and Sustainable Finance Certificate



## What is the Green and Sustainable Finance Certificate?

This global, benchmark qualification, updated for 2023, will help individuals to develop their knowledge, understanding and ability to apply the key principles and core practice of green and sustainable finance.

Global surface temperatures are likely to rise under all scenarios by more than 1.5°C above pre-industrial levels by 2040 and by more than 2°C later in the century without dramatic and sustainable reductions in greenhouse gas emissions. This underpins the urgency and importance of aligning finance with the objectives of the Paris Agreement, and sustainability in general.

In order to tackle this collective challenge, every finance professional needs to develop a knowledge and understanding of green and sustainable finance.

## Who should study the qualification?

The broad introduction on this qualification makes it suitable for a range of individuals:

**Bankers, insurers, investment managers, central bankers and regulators, risk managers, analysts and consultants** - If you are already a financial services professional, or wish to become one, this qualification can lead to further areas of study or practice in this area.

**Firms** - Firms wishing to increase their staff knowledge in this area could also use this qualification in induction materials.

**UK and global audiences** – The certificate includes broad financial services sector coverage which is relevant internationally.

## Studying for this qualification

130 hours of study is required for this level 4 exam. Supported by an updated Green and Sustainable Finance Principles and Practice, the world's first Practitioner Guide, the certificate is delivered via an online study guide which breaks up learning into bite size units. Each unit is followed by a short concept-check test or quiz to ensure understanding of the material.

Learning materials are delivered via the Chartered Banker Institute's learning management solution, which enables learners to access them anywhere, anytime, using most computer, tablet and mobile devices.

Employers can track progress of individuals and cohorts through regular progress reports and learner analytics, enabling timely intervention when necessary. A range of blended support options for employers (eg, tuition, revision workshops) are available on request.

The 12 unit programme can be completed in as little as 12 weeks. However, registration lasts for 1 year, so you can also work through at your own pace.

## Assessment

The qualification is completed by passing a one-hour-thirty-minute exam of 75 multiple-choice questions. Exams are booked via the Chartered Banker Institute and are delivered online, via remote invigilation, with instant results.


